

# DIY Sumo Suit Hire Agreement

*Safety is paramount in order for you to get the most fun and enjoyment from our DIY Sumo Suits. Observe these instructions. If there is anything you do not understand or are unsure of please do not hesitate to ask.*

**Equipment**

**Mats**

The mats provided are to be used for suits with all of the DIY Sumo Suit equipment and with this equipment only. It is highly recommended that a grassy area is used for this activity. The mat should be given plenty of space, at least 3m around the mat should be clear of dangers and spectators.

**Condition of Equipment**

No eating, drinking, shoes, glasses, jewelry, buckles, key-rings, pets, toys, other sharp or dangerous objects, liquids or materials, or similar items which could cause injury or damage allowed on, in or near the DIY Sumo Suit equipment at any time.

If damage or safety concerns with the equipment arise the hirer is required cease the use of the equipment, prevent further damage to the equipment, and report to the Funtime Kids Parties delivery staff upon agreed pickup.

All equipment must be returned in an acceptable condition – clean and undamaged.

**Participants**

**Liability**

It is highly recommended for the hirer to use the Funtime Kids Parties Participant Release Form. A copy of this form is available from the Funtime Kids Parties website, and a printed copy has been provided along with this Agreement for your use at the event. The Participant Release Form is to indemnify the hirer against claims, demands. Losses and liability arising out of the use of the Funtime Kids Parties DIY Sumo Suit Hire.

**Protective Equipment**

Make sure that all the protection supplied is being worn. Make sure that the helmet is being worn and securely fitted onto the participant's head. Ensure that the body suit and gloves are correctly worn whilst participating. If anyone refuses to use the equipment, they can not participate in the event.

**Event**

**Supervision**

The wrestling event should be supervised by two responsible adults at all times. If it is not supervised for any amount of time then the event should be shut down with no one to participate until it is fully supervised again.

**Fun**

The idea of the using the game is to force your opponent onto the mat on the ground or outside of the circle of the mat, not to beat or hurt them as hard as you can. Keep things light-hearted.
